

Nancy Langlois School of Dance: Waiver of Liability and Indemnification Terms

I, the parent or legal guardian of the participant named below (if under age 18), or the participant themselves (if age 18 or older), in full recognition and appreciation of the inherent risks associated with participation in activities offered by Nancy Langlois School of Dance (the "School"), hereby acknowledge and agree to the following legally binding terms.

Section One: I understand and acknowledge that participation in dance, tumbling, acrobatics, physical conditioning, classes, rehearsals, performances/recitals, community events, competitions, transportation, events, intensives, bootcamps, workshops, and all related activities ("Activities") carries inherent physical and emotional risks, including but not limited to: bodily injury, permanent disability, paralysis, death, exposure to illness or infectious disease, property damage or theft, psychological or emotional distress, and emergency medical events or errors. I fully understand the nature of these risks-particularly in acrobatics and tumbling, which may involve inversion, balance, spotting, and flipping, and I assume full and sole responsibility for all such risks, whether foreseeable or unforeseeable. The School shall not be held liable for injuries resulting from a participant's last minute judgement, or improper execution of a skill they are otherwise trained and capable of performing. To the fullest extent permitted by New York State law, I voluntarily and irrevocably waive, release, acquit, and forever discharge Nancy Langlois School of Dance and its owners, directors, employees, staff, independent contractors, assigned representatives/volunteers, affiliates, successors, and landlords/property owners, sponsors, host facilities, vendors, or event partners connected to studio events and travel ("Released Parties") from any and all claims, causes of action, liabilities, losses, or damages whether known or unknown, arising from or related to participation in Nancy Langlois School of Dance Activities. This waiver applies to claims involving negligence or alleged negligence, whether active or passive, and covers any incident related to the Activities, whether occurring on studio property, at an off-site event, or while traveling.

Section Two: I agree to fully and unconditionally defend, indemnify, and hold harmless the Released Parties from and against any and all claims, demands, judgements, legal costs, attorney fees, and liabilities that arise out of or are connected to my (or my child's) participation in Nancy Langlois School of Dance and all activities, any medical situation that occurs on or off-site, any behavior, negligence, or misconduct by me (or my child or guests), any damage to studio property, bathrooms, equipment, or facilities caused by me, my child, or our guests, whether intentional, negligent, or due to failure to follow posted rules.

Section Three: I certify that I (or my child) am in good health and capable of participating in all studio related physical activities. In the event of an emergency, I authorize Nancy Langlois School of Dance and its representatives to seek emergency medical care. I agree that I am solely financially responsible for all resulting services. I understand that the School does not carry accident or health insurance. I affirm that I maintain valid, continuous insurance coverage for myself (or my child).

Section Four: By signing this agreement, I understand and agree to the following: Monthly tuition is due the first class week of each month. Late fees will be added to unpaid accounts. Weekly payments are allowed, but a \$75 per dancer surcharge will be billed mid-season to cover administrative costs. All balances must be paid in full for participation in classes, shows, and competitions. No refunds or make up classes will be provided for missed classes.

Section Five: I understand that it is my responsibility to monitor weather cancellations or emergency delays on the School's official Facebook pages or website. No individual messages will be sent. A list of holidays/vacations is posted on our studio policies page, and a two-month calendar is posted in the studio. Missed updates will not exempt me from any responsibility or studio policy.

Section Six: I grant Nancy Langlois School of Dance and its official photography partner, Mossey Media, the unrestricted, royalty-free, perpetual, and irrevocable right to photograph, film, and publish images or video of me (or my child) during studio activities. This includes permission to: use media for studio and photographer marketing, including social media, websites, ads, and print, use footage or images in community and media promotions, and archive and reuse media indefinitely. I waive all rights to inspect, approve, or receive compensation for any such usage. I understand this applies regardless of whether the media is created by the studio, Mossey Media, or another authorized partner.

Section Seven: I acknowledge that I have read and understood all Nancy Langlois School of Dance policies, including those posted online or in-studio. I understand that policies may be updated at the School's discretion and that it is my responsibility to stay informed and in compliance. I understand that the School may remove any dancer or family for violations without refund. This agreement shall be governed by and construed in accordance with the laws of the State of New York. Any legal action or proceeding arising out of or related to this agreement shall be brought exclusively in the courts located in Clinton County.

By signing below, I confirm that I have read and understood this legally binding agreement. I acknowledge that I am waiving certain legal rights, including the right to sue Nancy Langlois School of Dance or its affiliates, and I voluntarily agree to all of the above terms.
